**OBJECTION**

COMES NOW Objector, by and through undersigned counsel, and files this Objection to Annual Wage Order No. 24, and states as follows:

1. The Contractor Survey Report which was relied upon to establish the rate in proposed Annual Wage Order No. 24 for the "Carpenter" (Building) Occupational Title in Ste. Genevieve County was submitted to the Division by Objector. That Report identified ten thousand seven hundred and seven (10,707) hours worked at \$29.86 per hour, plus fringes of \$16.06 per hour. Those hourly rates are incorrect.

2. Attached is the corrected Contractor Survey Report for Ste. Genevieve County, which accurately identifies ten thousand seven hundred and seven (10,707) hours of work at the corrected rate of \$25.02 per hour in wages, plus fringes of \$16.10 per hour.

WHEREFORE, Objector respectfully requests that the Labor and Industrial Relations Commission consider favorably the Objection of Objector and revise the basic hourly wage rate in Genevieve County for the "Carpenter" (Building) Occupational Title, as described herein, to reflect the prevailing practices throughout the geographic jurisdiction in question, and for such other changes as are deemed appropriate.


