

MEMORANDUM AND JUDGMENT

This Court has jurisdiction over the subject matter and all parties involved in this case. On November 17, 2008, this Court entered an interlocutory default judgment against Defendant, Barrett Kyle St. Onge, individually and as agent of Ryansk, LLC.

On May 11, 2009, this Court heard argument on Plaintiff's Motion for Default Judgment against Defendant Ryansk, LLC. This Court enters an order finding that Plaintiff effected service on Ryansk, LLC through personal service on Defendant Barrett Kyle St. Onge, individually and as agent of Ryansk, LLC. This Court further finds that Plaintiff demonstrated substantial efforts to obtain service on Ryansk, LLC through all other methods described in Missouri Supreme Court Rules 54.12 and 54.16, and thereby concludes that service by

publication was effective in this matter. This Court also heard testimony on damages in this matter on May 11, 2009. The Court finds this testimony to be credible.

This Court grants Plaintiff's Motion for Default Judgment against Defendant, Ryansk, LLC and Defendant, Barrett Kyle St. Onge, individually and as agent for Ryansk, LLC. This Court finds that each allegation listed in Plaintiff's Two Count Petition have been proven. This Court awards actual damages in the amount of \$50,000 and punitive damages in the amount of \$100,000 for each Count listed in Plaintiff's Petition.

Therefore, in regard to Count One – Linda Travers, this Court enters an award of judgment for Plaintiff and against Defendants in the amount of \$50,000 in actual damages and \$100,000 in punitive damages. In regard to Count Two – Thomas Orzech, Jr., this Court enters an award of judgment for Plaintiff and against Defendants in the amount of \$50,000 in actual damages and \$100,000 in punitive damages. The Court further orders Defendants to cease and desist all discriminatory behavior in all property owned and operated by Defendants. Costs are assessed against Defendants. This is the final judgment of this Court.
