Please be advised that I represent Maryville Glass & Lock, who would like to file an objection to the Annual Wage Order No. 17.

I understand the deadline to file such an objection is April 9<sup>th</sup>, 2010.

Maryville Glass and Lock Co. submitted on February 1, 2010 a contractors' report of construction wage rates for Nodaway County along with Worth, Atchison, Harrison, and Holt Counties.

Based on their submission the wage that was set for the glazier in Nodaway County is not the rate which reflects the prevailing rate paid within the locality and they would like to have that rate reviewed.

It is believed that there may have been a problem in the communication or receipt of the sheet submitted for Nodaway County due to the wage information submitted for the counties of Worth, Atchison, Harrison and Holt used to create the wage schedule for those areas was part of the packet sent along with the Nodaway County submission.

Maryville Glass and Lock has participated in this program for many years and felt certain it had communicated the required information in an acceptable and complete manner.

We respectfully request the Commission to review this situation and find that an error has occurred and allow their wage and hour information to be considered for Annual Wage Order #17.


