MOTION TO INTERVENE

COMES NOW, the International Association of Bridge, Structural, Ornamental and Reinforcing Iron Workers, Local Union No. #396 (“Iron Workers Local #396”), and does hereby move to intervene in the above-referenced Objection. In support of its Motion to Intervene, Iron Workers Local #396 avers as follows:

1. Intervenor Iron Workers Local #396 is an unincorporated association whose offices are located at 2500 59th Street, St. Louis, Missouri 63110.
2. Iron Workers Local #396 represents individuals who perform construction work within more than fifty (50) counties in the State of Missouri under the Occupational Title of “Ironworker” under 8 C.S.R. § 30-3.060.
3. The Glaziers, Architectural, Metal and Glass Workers Local Union No. 513 (“Glaziers Local 513”) has filed Objection No. 068-182 seeking amendments to the existing work description for the Occupational Titles of “Glazier” and “Ironworker” under 8 C.S.R. § 30-3.060.
4. Ironworkers Local #396 has a presumptive interest in this Objection since Glaziers Local 513 is seeking to delete a portion of the existing work description for the Occupational Title of “Ironworker”.


