

AMENDED CERTIFICATION OF REPRESENTATION


An election having been conducted in the above matter under the supervision of the Chairman of the State Board of Mediation in accordance with the Rules and Regulations of the Commission; and it appearing from the Tally of Ballots that an exclusive bargaining representative has been selected; and no objections having been filed to the Tally of Ballots furnished to the parties, or to the conduct of election, within the time provided therefor;

IT IS HEREBY CERTIFIED that International Association Of Machinists and Aerospace Workers, AFL-CIO, has been designated and selected by a majority of the employees of the above named Respondent, in the unit described below, as their exclusive bargaining representative. Pursuant to Section 105.525, RSMo. 2000, said organization is the exclusive representative of all the employees in such unit for the purpose of discussions with respect to salaries and other conditions of employment.

Unit: All full-time and part-time Fleet Maintenance Technicians (1-4), Laborers, Welders, Truck Tire Service Workers, and Fleet Maintenance Parts Specialists currently employed by the Equipment Services Division of the Board of Public Service; excluding office clerical employees, professional employees, managerial employees, guards and supervisors as defined by the Act.
