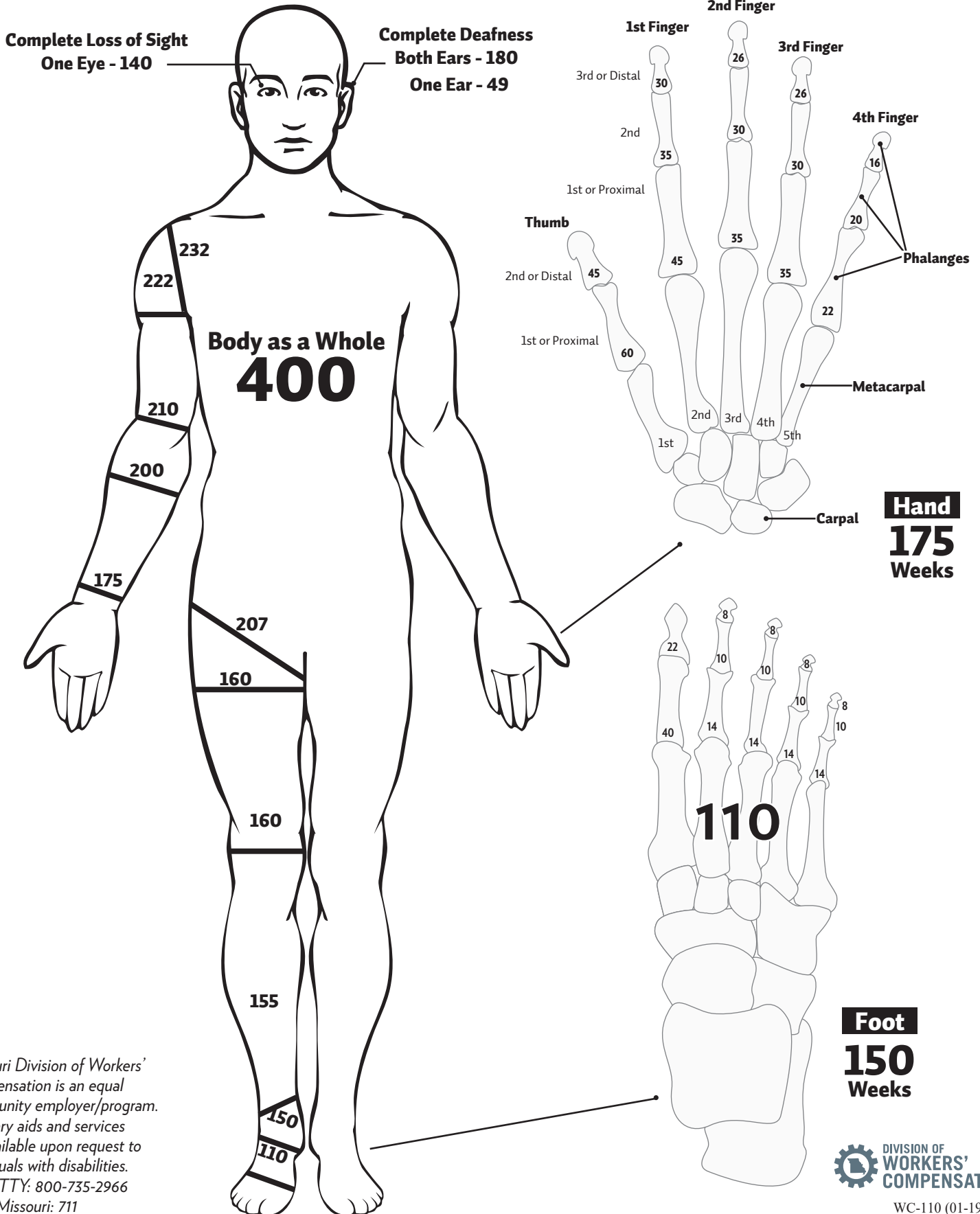


# CHART NUMBER 1 PERMANENT PARTIAL DISABILITY

Visual chart showing number of weeks of compensation payable for scheduled and non-scheduled permanent partial disabilities. When there is a complete loss of a member, either by severance or loss of use, the number of weeks indicated on this chart for such member(s) is increased by ten percent (eye injuries being specifically exempted from such increase.) Scheduled disabilities are governed by section 287.190.1 RSMo. Non-scheduled or "Body as a Whole" injuries are governed by section 287.190.3 RSMo.
